# Saltash & District Camera Club - Data Privacy Policy

### **1. About this Policy**

1.1 This policy explains when and why we collect personal information about our members, how we use it and how we keep it secure and your rights in relation to it.

1.2 We may collect, use and store your personal data, as described in this Data Privacy Policy and as described when we collect data from you.

1.3 We reserve the right to amend this Data Privacy Policy from time to time without prior notice. You will be advised of any amendments.

1.4 We will always comply with the General Data Protection Regulation (GDPR) when dealing with your personal data. Further details on the GDPR can be found at the website for the Information Commissioner (<u>www.ico.gov.uk</u>). For the purposes of the GDPR, we will be the "controller" of all personal data we hold about you.

#### 2. Who are we?

2.1 We are Saltash & District Camera Club. The Club's Honorary Secretary, Peter Addelsee, who is the Club's Data Controller, can be contacted through the form on the Contact page of the web site.

#### 3. What information we collect and why

<b>Club Officers</b> Name, e-mail address and telephone number.	Information published on the Club's website, in the Club's annual programme and other publications, in each case as a point of contact at the Club.	For the purposes of our legitimate interests in operating and promoting the Club.

#### 4. How we protect your personal data

- 4.1 We will not transfer your personal data without your consent.
- 4.2 We have implemented generally accepted standards of technology and operational security in order to protect personal data from loss, misuse, or unauthorised alteration or destruction.
- 4.3 Please note however that where you are transmitting information to us over the internet this can never be guaranteed to be 100% secure.

4.4 We will notify you promptly in the event of any breach of your personal data which might expose you to serious risk.

## Who else has access to the information you provide us?

4.5 We will never sell your personal data. We will not share your personal data with any third parties without your prior consent (which you are free to withhold) except where we are required to do so by law or as set out in the table above.

## 5. How long do we keep your information?

5.1 We will hold your personal data on our systems for as long as you are a member of the Club and for as long afterwards as it is in the Club's legitimate interest to do so or for as long as is necessary to comply with our legal obligations. We will review your personal data every year to establish whether we are still entitled to process it. If we decide that we are not entitled to do so, we will stop processing your personal data except that we will retain your personal data in an archived form in order to be able to comply with future legal obligations e.g. compliance with tax requirements and exemptions, and the establishment, exercise or defence of legal claims. 6.2 We securely destroy all financial information once we have used it and no longer need it.

## 6. Your rights

6.1 You have rights under the GDPR:

- (a) to access your personal data
- (b) to be provided with information about how your personal data is processed
- (c) to have your personal data corrected
- (d) to have your personal data erased in certain circumstances
- (e) to object to or restrict how your personal data is processed
- (f) to have your personal data transferred to yourself or to another organisation in certain circumstances

7.2 You have the right to take any complaints about how we process your personal data to the Information Commissioner. Please allow Saltash & District Camera Club to deal with your complaint first.
